## PROTECTING CIVIL LIBERTIES

### IMMIGRATION DELAY RESOLVED

*"I wanted to take this opportunity to let you know how much I appreciate your assistance. The way you followed up on my case and showed interest and enthusiasm is truly commendable. May Allah (swt) reward you with the best."*

These are the words of a South Asian Muslim who attained his work permit in October of 2008, after months of delay. CAIR-Philadelphia used its network of immigration resources to find the representation he needed to solve his problem.

### ADVOCATING FOR ISLAMIC PROTOCOLS IN STATE PRISON

CAIR-Philadelphia responded to a state prison inmate complaint of a Corrections Officer improperly disposing of his confiscated Qur'an.

Our advocacy resulted in a letter from the Director of Religious support services stating that the Islamic guidelines of disposal will be implemented.

### UPDATE ON PHILADELPHIA POLICE CASE

In September 2008, the U.S. 3rd Circuit Court of Appeals heard oral arguments in the case of a Muslim police officer whose requests to wear a headscarf in uniform were denied by the Philadelphia Police Department.

CAIR-Philadelphia aided this officer in her struggle for religious accommodation by securing representation and coordinating an amicus brief in support of her appeal. We are currently awaiting a ruling from the Court of Appeals. If it is not in her favor, CAIR-Philadelphia may call on the Muslim community to support this courageous sister.

### IMMIGRATION INFORMATION SESSION

In November, CAIR-Philadelphia and the United States Citizenship and Immigration Services (USCIS) held our first Immigration Information Session at the Foundation for Islamic Education.

Members of the Muslim community came forward with questions and comments regarding specific immigration issues. Insha'Allah we are planning to hold more sessions throughout the year on a quarterly basis.

## EMPOWERING AMERICAN MUSLIMS

### CAIR-PHILADELPHIA INTERNSHIP PROGRAM

Our interns work with the staff on substantive projects that lay the foundation for a more active and vibrant Muslim community. The culmination of their work is currently being used by our civil rights interns. Because of the efforts of Uzma and Afshan, CAIR-Philadelphia now has an increased capacity to handle discrimination complaints.

CAIR-Philadelphia offers tremendous opportunities for students to exercise significant responsibility which demonstrates their value to future employers.

## ENHANCING UNDERSTANDING OF ISLAM

### MEDIA BREAKFAST

In December of 2008, CAIR-Philadelphia hosted its *Inaugural Media Breakfast* for a small group of media professionals. The theme of this year's breakfast was Hajj: Islam's Annual Pilgrimage. The event gave chapter staff an opportunity to provide information about CAIR and to give local journalists a presentation explaining the rituals of Hajj.

The outreach efforts initiated during this event represent the first in a series of small steps towards building relationships necessary to facilitate an accurate portrayal of Islam and Muslims in the media.

### COURSES & PRESENTATIONS

In October and November of 2008, CAIR-Philadelphia also completed our first offering of "Understanding Political Islam" at a church in Delaware County. This eight part course covered the development of political institutions and expressions in Muslim history.

This past fall CAIR-PA representatives also gave a three part introductory presentation on Islam to Middle School students in Bucks County and a church group in Chester County.

### DIALOGUE

During the fall of 2008, CAIR-Philadelphia representatives led a group discussion with Villanova University students on Muslims in America, and participated in a four-part seminar entitled "Understanding Islam and Muslims in the Modern World" at a synagogue in Montgomery County.

## BUILDING COALITIONS

### HUMANITARIAN DELEGATION

In November, CAIR-Philadelphia President, Dr. Mazhar Rishi, participated in the North American Medical Delegation follow-up visit to Syria. The purpose of the last visit in May of 2008 was to assess the Iraqi refugee situation.

Some of the 1.5 million Iraqi's that have migrated to Syria explained heart-breaking stories of how the violence has affected their families. The delegation assisted in the distribution of infant formula to refugee mothers who could not breast-feed their children due to malnutrition.

### USCIS Community Meetings

CAIR-Philadelphia's Civil Rights Director, Marwa El-Turky, attends quarterly community organization meetings with the United States Citizenship and Immigration Services (USCIS). During these meetings, she receives updates on new legislation regarding the U.S. immigration process and she is also able to put forth comments and community concerns to the USCIS.

### PHRC Community Meeting

Marwa also participates in monthly meetings of the PA Inter-Agency Task Force on Civil Tension hosted by the Pennsylvania Human Relations Commission (PHRC).

We receive summaries of bias-related incidents occurring in Pennsylvania as well as presentations on their organization's objectives, and how they confront hate-crimes and discrimination.

CAIR-Philadelphia continues to share incidents of religious discrimination against Muslims. In a recent meeting, we have brought about issues regarding the response towards Muslims after the release of the *Obsession* film.

### MOS/AMLEOA Annual Dinner

CAIR-Philadelphia's Executive Director, Justin Peyton, travelled to Brooklyn, New York to attend the Muslim Officer's Society (MOS) & American Muslim Law Enforcement Officers Association's (AMLEOA) annual family dinner.

Supporting these two organizations was in furtherance of a relationship that began approximately one year ago when AMLEOA agreed to support CAIR-Philadelphia's most high-profile case to date, that of a Muslim police officer struggling to wear a hijab in uniform (see page 2).

## VISION & PRIORITIES

CAIR's mission is to enhance understanding of Islam, encourage dialogue, protect civil liberties, empower American Muslims, and build coalitions that promote justice and mutual understanding.

### STRATEGIC VISION

CAIR-Philadelphia has prioritized the "pillars" of our mission statement to establish a strategic direction for the development of our programs and services over the next couple of years.

Our main effort will be *empowering American Muslims*. An empowered community can integrate into the fabric of American society without losing its Islamic identity and make positive contributions for the benefit of all Americans.

Our first supporting effort will be *protecting civil liberties*. Acts of discrimination and defamation disenfranchise individuals, marginalize communities and prevent full participation in society, thereby reducing the diversity which makes our nation great.

Our second supporting effort will be *enhancing understanding of Islam and encouraging dialogue*. Proactive educational efforts at public and private institutions are the best way to eliminate negative stereotypes and ignorance which lead to acts of discrimination and defamation.

Our third and final supporting effort will be *building coalitions that promote justice and mutual understanding* because we realize the Muslim American experience is not unique. We must seek out and work with other groups who face similar challenges as well as fair-minded people who are not swayed by bigotry and hatred.

### 2009 PRIORITIES

**Priority 1** – Establish a *Muslim Youth Leadership Program* that prepares young Muslims to proactively address critical issues facing the Muslim community through enhancing understanding of Islam, community activism, civic engagement and public service.

**Priority 2** – Expand delivery of our immigration information sessions, civil rights seminars and workshops in order to educate Muslims on their rights and assist them in resolving problems.

**Priority 3** – Open new lines of communication in order to galvanize local Muslims around issues facing our community and enhance positive coverage of Islam in the local news media.
