# SPECIAL FEATURE: POLICE vs. HIJAB

Since September 2007 CAIR-Philadelphia has been assisting a Philadelphia police officer in her struggle to obtain a religious accommodation to wear a headscarf while in uniform. In April we learned the U.S. 3<sup>rd</sup> Circuit Court of Appeals denied her appeal, thus allowing the police department to continue prohibiting her from adhering to her faith. Undaunted by this setback to the integration of Muslims into all spheres of American society, the officer is considering an appeal to the U.S. Supreme Court.

In the meantime however, CAIR-Philadelphia will not rely solely on the judicial system to protect our rights. Instead, we will be formulating an advocacy campaign to petition elected officials, if necessary, to have the police department incorporate religious accommodations into its uniform policy. But we need your help in persuading Philadelphia to recognize and respect the diversity of its citizens by allowing public safety officers to adhere to their faith.

Success will only come through collective action so we at CAIR-Philadelphia ask that in the coming months, each one of you take it upon yourself to respond to our calls to sign petition letters, send emails, and make phone calls to the mayor and city council-persons of Philadelphia.

# IMMIGRATION INFORMATION SESSION

In February, CAIR-PA held our second Immigration Information Session in partnership with the United States Citizenship and Immigration Services and the Philadelphia Arab American Community Development Corps at Al-Aqsa Islamic Society. Two immigration officers and a community outreach specialist were on site to present on the U.S. immigration process and meet one-on-one to answer question from the 100+ attendees.

# ADVOCATING AGAINST WRONGFUL TERMINATIONS

In March a Hispanic female satisfactorily resolved a complaint against her former employer regarding allegations that she was wrongfully terminated after a series of incidents in which she was improperly disciplined for actions employees of other faiths were not disciplined.

CAIR-Philadelphia had been assisting this women since March 2008, by sending her employer an advocacy letter and supporting her through the PA Human Relations Commission complaint process.

# "KNOW YOUR RIGHTS" PRESENTATIONS

This year CAIR-PA resumed offering "Know Your Rights" presentations which provide information on individual's rights in common situations such as work, school or when contacted by law enforcement. Our first session was held in March at the Foundation for Islamic Education and our second in April at Masjid Al-Jamia. Both saw a large turn-out where attendees had the opportunity to ask questions and file complaints.

## EMPOWERING AMERICAN MUSLIMS

## GAZA CAMPAIGN

In January of 2009 CAIR-Philadelphia participated in a nationwide campaign to protest Israeli aggression against the Palestinian people. Locally, we collected 995 signed letters at mosques throughout the Delaware Valley for presentations to members of Congress by our National Legislative Director. CAIR-Philadelphia also co-sponsored the "Let Gaza Live" National March on Washington and helped organize 5 busloads of Philadelphians to make the trip to DC.

#### **CAIR-PHILADELPHIA INTERNSHIP PROGRAM**

In the first quarter of 2009, CAIR-Philadelphia continued to develop its internship program. Afshan Ali of Temple University returned for a second semester and served as a Civil Rights intern. Under the supervision of Civil Rights Director, Afshan directly handled complaints by interviewing those who experienced discrimination, analyzed case facts and drafted advocacy letters.

Also joining us this semester as a Civil Rights Intern is Kylie Smith of Cecil College in northeast Maryland. Kylie is very passionate about civil rights and is a huge advocate of grassroots organizations. Kylie is undertaking a research project entitled "Marginalized Minorities in 20th Century America," which seeks to draw lessons for contemporary Muslims from the historical treatment of other minority groups.

Our third intern is Tylar Kelly, a student at Rustin High School in West Chester. Tylar has a passion for interfaith activities and is interested in learning more about Islam. His main project is video recording our 10-part Understanding Islam through History and Jurisprudence in preparation for wider dissemination via the internet and other media.

#### **INTERFAITH TRAINING**

In January of 2009, a small entourage of CAIR-Philadelphia staff and volunteers travelled to Pittsburgh to conduct an intensive two-day instructor's Training for presenting the 10-part course "*Understanding Islam and Muslims through History and Jurisprudence*". About eight volunteers from our newly formed Pittsburgh office learned how to teach this course to groups in Western PA.



## **COURSES & PRESENTATIONS**

From January through March, CAIR-Philadelphia taught it's highly popular Course "*Understanding Islam and Muslims through History and Jurisprudence*" at two churches in West Chester, PA.

During March 2009, CAIR-Philadelphia Executive Committee members gave several presentations across the Greater Philadelphia area. Among them were "Women of the Muslim Faith" at a church in West Chester, "The View of the Other and the Reality of Violence" at Drew University in New Jersey, "Jesus in the Islamic Tradition" at Lutheran Theological Seminary in Philadelphia and "The View of the Other in Qur'anic Text" at Holy Family University in Philadelphia.

## **DIALOGUE**

In February, Central PA public television station WITF aired Faith, Politics and Society: Muslims in America, featuring a panelist from the CAIR-Central PA office. In March, CAIR-Philadelphia participated in a group discussion with Villanova University faculty on teaching Islamic source text titled "Tools in the Islamic Jurisprudence Toolbox."

#### **BUILDING COALITIONS**

## MOSQUE OUTREACH

In February and March our Executive Director met with the Imams of (3) inner-city Philadelphia mosques in order to offer our services to members of their respective communities, learn of any community issues that CAIR might be able to address and establish mutually beneficial working relationships. All were open to working in partnership with CAIR-Philadelphia and we look forward to collaborating with them on future projects.

#### MUSLIM STUDENT OUTREACH

In February our Executive Director attended the meeting of a local high school Muslim club where, he gave a half hour presentation on CAIR and the work we do for the community, fielded questions, and then participated in club activities. The Executive Director also attended an MSA dinner at the University of Pennsylvania in February, in which he had the opportunity to meet members of various local MSA's, speak about CAIR and what we do and begin establishing mutually beneficial working relationships.



# **USCIS COMMUNITY MEETINGS**

CAIR-PA's Civil Rights Director attends quarterly Community Organization Meetings with the United States Citizenship and Immigration Services (USCIS) to discuss immigration issues and exchange ideas on how to better assist individuals through the immigration process. During the most recent meeting in February, CAIR-PA was able to announce and advertise our Immigration Information Session.

# **PHRC COMMUNITY MEETINGS**

CAIR-PA's Civil Rights Director also participates in monthly meetings of the PA Inter-Agency Task Force on Civil Tension hosted by the Pennsylvania Human Relations Commission, during which we receive monthly summaries of bias-related incidents in PA. CAIR-PA has the opportunity to share incidents of religious discrimination against Muslims and most recently shared a March incident in which two students in Pittsburgh were sent home from school for wearing the Palestinian Keffiyah (scarf).

#### COMMUNITY CORNER

## **IMAM'S ROUNDTABLE: COMMUNITY EMPOWERMENT**



What is Community? Community is being self sufficient and not having to go outside of the community for anything. What is Empowerment? Empowerment is education and economics. In order to have Community Em-

powerment, you must first establish four influences in the environment. The first of those influences is the supernatural influence, meaning to call the people back to G-d to get them praying, worshipping and asking G-d for what they need. The second influence is the educational influence, meaning teaching the people the basic knowledge of how to read and write so that they're educated and can worship properly. The third influence is the economic influence, so that people have jobs, money, businesses, schools and good housing situations. And the fourth influence is the political influence, so that you elect people that can guard your interest so that you are able to pray, able to learn, able to have jobs, business, schools and good housing situations. Once you have these things people are going to try to take them from you unless you have someone who can guard your interest. And G-d says that once you establish these four influences that you have given life to the dead, in other words you have empowered the community.
