### ADVOCATING AGAINST WORKPLACE DISCRIMINATION AND WRONGFUL TERMINATION

A Muslim woman in Philadelphia was fired from her job at a nursing home for wearing the hijab. She came to CAIR-Philadelphia immediately for assistance. CAIR-Philadelphia's Civil Rights Director wrote a letter to her then former employer firmly stating the woman's religious rights in the workplace. Additionally, that her right to wear the hijab is protected by the constitution of the United States and by the Pennsylvania Human Relations Act, and her firing was unjust. After negotiations, the employer has agreed to allow the sister to return to work with the hijab. She will receive fair compensation for all lost wages. This case was handled without any involvement of a government agency or litigation and resolved within 3 weeks of the initial complaint. This demonstrates CAIR-Philadelphia's ability to protect the rights of Muslims swiftly

### ANTI-ISLAM PROPAGANDA

CAIR-Philadelphia was informed by a former local area High School Student that the anti-Muslim film, Obsession, was in a course syllabus for a Social Studies class. CAIR-Philadelphia sent out a letter immediately explaining the contents of the film and how the film promoted hate and fear against Muslims. The Civil Rights Director suggested that the class bring in Muslim guest speakers to inform the students on Islam and Muslims. The school responded promptly and informed CAIR-Philadelphia that the specific course has not been offered for a few years and the school administration vowed that they would not show this film under any circumstances.

### **GOVERNMENT RELATIONS**

CAIR-Philadelphia will initiate Civic Participation Workshops, emphasizing government engagement and education. Our society has many layers of government, from the President of the United States and Congress, to local county boards, mayors, and superintendents. It is important for the Muslim community to learn how to engage at all levels of government so that when policy decisions that impact the community are made, they are done so with consideration of the Muslim American point of view. These new workshops from CAIR-Philadelphia will explain who our local, state, and federal officials are, how to contact their offices, and how to proactively participate in the democratic process. In particular cases, we will conduct letter writing campaigns and phone banks regarding specific issues such as foreign policy, local PA issues, as well as nationwide issues such as the current

health care debate. To provide our youth with work experience, interns are preparing course material under the supervision of our Civil Rights Director. We anticipate launching this program within a quarter.

### MUSLIM YOUTH LEADERSHIP PROGRAM (MYLP)

CAIR-Philadelphia completed the Fall 2009 Conference of the Muslim Youth Leadership Program, which focused on Civil Rights and Advocacy. 15 students, both male and female, from grades 9-12 participated in the two days of activities, and were engaged in the training and information sessions provided.

The program, the first of its kind in the Philadelphia-Delaware Valley area, received mainstream media coverage in the Philadelphia Tribune. (Visit the Media section of our website (In the News) for the complete article.)

Presenters included the American Civil Liberties Union (ACLU), the Pennsylvania Human Relations Commission, the Pennsylvania Institutional Law Project, in addition to staff from CAIR-Philadelphia and others. Workshops and interactive presentations covered a wealth of information crucial to the development of the next generation of activists, advocates and community leaders.

Our youth were enthusiastically engaged and already looking forward to the upcoming Winter 2009 session in December.

### **COURSES AND PRESENTATIONS**

During the past quarter, CAIR-Philadelphia continued to be consistently active and engaged in presenting Islam in a accurate, balanced and fair manner.

In August, CAIR-Philadelphia presented Tell Me About Islam at the Free Public Library, Central Branch in Center City Philadelphia; this was the first program of it's kind held by CAIR at a public library.

CAIR-Philadelphia also continued offering an ongoing series courses, including weekly classes on Understanding Islamic Jurisprudence at the Foundation for Islamic Education in addition a 10-week course titled Political Islam at the Grove Methodist Church West Chester and another just completed at Lutheran Seminary titled Islam & Muslims.

In September, CAIR-Philadelphia helped organize Sharing Ramadan events at the Zubaida Foundation, Yardley, PA and the Foundation for Islamic Education, Villanova, PA, in addition to giving a presentation at the Devon Mosque, Devon, PA.

CAIR-Philadelphia is actively engaging the administration/leadership of area institutions, both to offer the programs and services of CAIR, as well as discussing ways to collaborate in the shared mission of empowering Islam and Muslims in America. In addition to the Sharing Ramadan events, CAIR-Philadelphia continues to build bridges with other faith traditions in areas of collaboration and common interest.

Our Outreach Chairperson participated in the local observance of the UN International Day of Peace local observance, distributing information about Islam, as well as serving as the Mistress of Ceremonies. Also participated in monthly meetings with interfaith peace group in Lower Buck County, PA.

CAIR-Philadelphia also participated in several meetings with a local area minister and rabbi, to develop and implement interfaith events for respective congregations and the general public. Also involved with coordinating interfaith events in conjunction with the Children's Defense Fund; a national organization dedicated to eradicating poverty for children, as well as protecting them from abuse and neglect and ensuring access to healthcare, education and a moral, spiritual foundation.
