A Year of Struggle


Back on January 21, 2017, the day after Donald J. Trump was sworn in as the 45th President of the United States of America, I marched with CAIR National Director Nihad Awad and perhaps a million other people through the streets of Washington, DC, to protest Trump's election and his policies of division, fear, and open bigotry.

Since the start of the last campaign for the American presidency, Muslims have been the main (although unsurprisingly, not the only) target of a wide range of Trump advisors, media pundits, and elected officials. Their well-funded campaign of hate has coincided with a documented rise of Islamophobia and hate crimes against Muslim targets across the country, in many cases including violence.

New FBI hate crimes statistics show that almost one-quarter of the victims of anti-religious hate crimes in the past year were Muslim. According to the FBI report, Jews and Muslims were the two most common targets of religiously-motivated hate crimes, with anti-Muslim hate crimes rising by nearly 20 percent.

Add to this the administration's repeated and unconstitutional attempts at a "Muslim Travel Ban," the moral blindness toward millions of refugees, and the draconian threats of a "Muslim Registry," and it is clear why many in the American Muslim community report that they are now a community living in fear.

CAIR's promise to you is that we will respond to that fear. On the one hand by providing the Muslim community with the organizing tools to overcome



their fear, and on the other hand by joining with allies in Christian, Jewish, and social justice communities to say "NO!" to the disastrous policies of this administration: No to Muslim Travel Bans! No to a Muslim Registry! No to turning away desperate refugees! No to religious and racial profiling! No to denials of climate change! No to the cutback of medical services! No to the continuation of wars in Afghanistan and the Middle East! No to the unconditional support of Israel and its occupation of Palestinian lands! And no to the building of walls of separation and subjugation!

These are indeed trying times. And as if we needed any further proof of this, intake calls to our office reporting incidents of anti-Muslim workplace discrimination, government violations of civil rights, and schoolyard bullying have increased 25% over last year.

The good news is that CAIR-Philadelphia has responded with expanded community organizing and a range of exciting and innovative programs that are described and illus-

trated in these pages.

Our office is now blessed to include —in addition to Leena Jaffer, our indispensable Office Manager—two new and talented colleagues: Timothy Welbeck, Esq., our Civil Rights Attorney, and Ahmet Selim Tekelioglu, PhD., our Director of Outreach and Education. The four of us—Muslims, Christian, and Jew—are dedicated to serving the Muslim community to the fullest extent possible during these difficult days.

None of these voluminous activities, however, can take place without the support of your Muslim community and its allies. So we turn to you, dear friends, to help us in our efforts to challenge the voices of violence and hate, and to secure the Muslim future in an America of justice, peace, and mercy.

2017 Civil Rights Roundup

This present era in United States history has revealed that America is who she has shown herself to be, not who she has said she is. The Declaration of Independence and the Bill of Rights for all their inspiring language and talk of liberty in addition to "certain unalienable rights" amounts to promises of freedom, but American history has taught many people of color and American Muslims that a promise of freedom does not necessarily amount to a guarantee of freedom. The Trump Administration has continued this tradition by seeking to establish policies that disenfranchise people of color, Muslims, women, the LGBT community, immigrants and refugees, and the poor.

In his iconic "I Have a Dream" speech, delivered at the 1963 March on Washington, Rev. Dr. Martin Luther King, Jr., said, "We have come to our nation's capital to cash a check. When the architects of our republic wrote the magnificent words of the Constitution and the Declaration of Independence, they were signing a promissory note to which every American was to fall heir." He added, "It is obvious today that America has defaulted on this promissory note..."

In a sense, we view our work at CAIR as a means in which to compel America to make good on its promises of freedom and religious liberty.

On August 1st, I began work at the Philadelphia Chapter of CAIR, and in





so doing continued the organization's storied history of defending the civil rights and civil liberties of the Muslim community, and working towards the eradication of Islamophobia. What follows is a summation of some of the more important work CAIR has done in that time in advancing this cause.

FREEDOM OF ACCOMMODATION

A Muslim man called our office and complained that his employer would not allow him to take the necessary time away from work so that he could go on *hajj*. I wrote a letter to his employer and followed up via telephone to ensure his employer allowed him to do so without penalty. The employer agreed, and he successfully completed his *hajj*.

FREEDOM OF RELIGION

Our former Civil Rights Attorney Ryan Houldin worked in conjunction with other organizations and law firms to facilitate an agreement between the United States Justice Department and the Bensalem Township to resolve a dispute stemming from the Township's denial of zoning approval which would have permitted Bensalem Masjid to build a mosque on three adjoining parcels of land in the Township. Bensalem Masjid and its advocates argued the refusal violated the Religious Land Use and Institutionalized Persons Act of 2000 (RLUIPA), which was enacted in part to prevent religious institutions from experiencing overly burdensome zoning restrictions. The Justice Department agreed that the Township behaved in a discriminatory manner, and filed suit against it. This agreement represents an enormous victory for religious liberty, particularly as it relates to the Muslim community of Bensalem and its surrounding areas. It is our hope the decision of the Justice Department will set a lasting precedent as well.

GOVERNMENT OVERREACH

A Muslim presented to our offices reporting that a police officer in

plain clothes and an unmarked car, approached him at work and arrested him. The man reported that the officer subsequently took him to a local police station; however, the officer never formally charged him with any crime, did not finger print him or process him. He was detained for a total of ten days, nine of which were in solitary confinement, then ultimately released without any formal charges brought against him. Our office is in the process of filing a false imprisonment suit on the man's behalf.

COALITION BUILDING

Our office joined the Montgomery County Fair Policing ad hoc committee, which includes representatives from the Norristown NAACP and People Power representatives. The ad hoc committee convenes to strategize and implement "Know Your Rights" seminars in addition to fair policing workshops in high schools within Montgomery County, along with other policy recommendations that would result in more equitable policing of marginalized citizens in Montgomery County.

Our office participated in a lobbying effort at the state capitol, along with other affiliates of CAIR, to solidify partnerships with state officials to further protect the civil rights and liberties of Muslims throughout Pennsylvania. We met with the Pennsylvania Human Rights Commission to discuss further working in partnership to fight against Islamophobia. We also met with a number of state legislators, regarding their support for the proposed legislation to renew Pennsylvania's hate crime law, in addition to sharing some of the unique concerns the Muslim community in middle Pennsylvania. Lastly, our coalition met with Pennsylvania Department of Homeland Security regarding how we may forge a more sustainable alliance between the Muslim community and government agencies.

In the Community

My first few months at CAIR-Philadelphia witnessed arguably the most beneficial learning curve in my life; and I say this despite having earned a doctorate in Political Science and worked as a professor in several universities.

On the interfaith scene, I continue to meet wonderful souls who are invested in building a mutually enriching future in America, even when it required engaging in difficult conversations.

In civilliberties work, led by Timothy, we often have to witness injustice and speak against bigotry, close-mindedness, and hatred. And yet, it is that amazing spirit of engaging in human rights work, along with a decisive, unapologetically Muslim American confidence, that helps us persevere in these trying times. I remind myself of this every single day.

OUR EDUCATIONAL OFFERINGS

One of my most significant accomplishments during my first three months as Outreach and Education Director was the completion of our brochure describing the workshops, seminars, and courses we are offering



free of charge to institutions throughout the Greater Delaware Valley. (A brief summary of the booklet can be found on the next page.)

Additionally, Timothy and I have conducted workshops on "Civic Engagement" at the Islamic Society of Greater Harrisburg, and I have visited United Muslim Masjid and North Penn Mosque, speaking with community members and listening to their concerns.

ADVOCATING FOR JUSTICE

I also made two trips to Harrisburg to engage with government officials and politicians in preparation for Muslim Capitol Day, which is now scheduled for April 24, 2018. While in Harrisburg, our group of Muslim activists led by Advisory Board Member Aaysha Noor met with Pennsylvania Secretary of Education Pedro Rivera; our talk focused on anti-Muslim bias in school curriculum and Islamophobic incidents in our schools. We held a follow up meeting in November with Pennsylvania Human Relations Commission (PHRC) and the Office of Safe Schools to discuss future concrete steps. We are working with multiple agencies and allies to ensure CAIR-Philadelphia contributes anti-bullying efforts state-wide and can provide cultural competency trainings for educators.

At CAIR-Philadelphia we especially value building interfaith and intergroup alliances. Our chapter has been very vocal in opposing injustice against any group, and in speaking out about such crucial issues as the climate crisis. We are engaging multiple non-profit and state-wide agencies to build these alliances of virtue, much alike in the example of our Prophet's (pbuh) role with Meccan institution of *hilf al-fudl*.

Part of my responsibilities as Education and Outreach Director is to visit mosques, get to know the community, and on occasion, given the honor of delivering the Friday *khutbal* sermon, in which I usually highlight the Islamic values of social justice and peace. I believe it is imperative for us to emphasize these key tenets of our faith time and again.



UPHOLDING A NOBLE PRINCIPLE.

Before I close my letter, I would like to request your duas/ prayers for a new chapter in our education and outreach services. Through the Islamic Community Center of Lancaster, I applied to be a volunteer chaplain with the Lancaster County Prison. Muslim inmates there have not had a jum'a service in a long time. Alhamdulillah/All Praise is to God, just recently we learned that my application is approved. Please pray for our incarcerated brothers and sisters and for the success of this new endeavour.It is our Muslim duty, brothers and sisters in faith, to protect both our rights as well as the rights of all people facing prejudice, persecution, or poverty. I am convinced that it is this simple and noble principle that will carry our society away from bigotry, hatred and short-sightedness.

I ask you to pray for all of us at CAIR-Philadelphia so we can serve you in the best way possible!
